Non-Residential Deposits

Delinquent nonresidential accounts without a continuing letter of guaranty from financial institution are required to pay a deposit equal to 25% of the delinquent bill. On 3rd consecutive delinquency, a deposit equal to 1/6th of the estimated annual billing will be assessed.

Residential Deposits

For residential consumers a deposit equal to 1/6th of the estimated annual billing is required if the account becomes delinquent three or more times in one year. After that year, the deposit may be refunded and applied to the next month's bill provided the account has not been delinquent in that year. If a service is disconnected, the deposit is applied to the final bill if all requirements have been met.

Recipe Corner: Best Ever Banana Pudding

1 box vanilla pudding 3.4oz
 1 can sweetened condensed milk
 2 8 oz tub cool whip
 Vanilla wafers-about 2 boxes
 Bananas 2 or as much as you like
 Lemon juice-enough to sprinkle on bananas

Mix the vanilla pudding, sweetened condensed milk and 1 can (from the sweetened condensed milk) of water, all together. Refrigerate for about five minutes to thicken. Take out and add 1 tub cool whip, mix all together and put back in refrigerator. Slice bananas and sprinkle with lemon juice so they don't turn brown right away. Once you're done start layering in a 9x13 pan. I usually start with cookies first, then pudding, then bananas and repeat. End with pudding then add tub of cool whip on top. Crush some of the cookies and sprinkle on top of cool whip. You can double or triple the recipe if you need a big batch. Enjoy!
