**APPLICABILITY:**

Available to irrigation consumers and/or peanut or grain dryers, three-phase, who are not on demand instrumentation.

**TERRITORY:**

All electric residential and commercial consumers served by RCEC in Roosevelt County and extending into portions of Curry, Lea, Chaves and De Baca counties.

**CHARACTER OF SERVICE:**

Alternating current, three-phase, 60 Hertz, at available secondary voltage.

**MONTHLY RATE:**

**TAX ADJUSTMENT:**

Billings under this schedule may be increased by an amount equal to the sum of taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state, and federal income (taxed) payable by the utility and levied or assessed by any government authority on the public utility service rendered, or on the right or privilege of rendering the service, or any other object or event incidental to the rendition of the service.

**IDLE SERVICE RATE:**

Consumers classified under this rate schedule may retain existing electric facilities (disconnected) on their premises by paying 60% of the established monthly minimum bill each month thereafter.

**MINIMUM CHARGES:**

The annual minimum charge under this schedule shall be \$22.50/HP/Year, but not less than \$225.00 per year.

The consumer shall receive credit against the annual minimum charge at the rate of \$.115647/KWH used during all months January through December. X  
Any remaining balance of the annual minimum as specified above and the credit as computed herein shall be due to the utility at the end of each calendar year.

The annual minimum charge specified herein shall not be less than established in accordance with the Cooperative's line extension policy.

**FUEL AND PURCHASED POWER COST ADJUSTMENT:**

Billings under this schedule shall be increased or decreased by any amount that the purchased power cost for the previous month differs from \$.069665/KWH sold, in accordance with NMPRC Rule No. 550. X

**DISTRIBUTED GENERATION (DG) NET METERING RATE RIDER:**

Billings under this rate rider shall have the following charges  
Billing/Meter Reading Cost \$4.51 per month  
Facilities Charge (per DG System Nameplate KW) \$5.72 per KW

**SURCHARGE:**

Billing under this schedule shall have a surcharge of 1% in order to procure renewable energy, invest in renewable energy projects or promote energy conservation and load management.

**TERMS OF PAYMENT:**

All bills under this rate are due and payable when rendered and become delinquent twenty (20) calendar days after the billing date.


**TERMS AND CONDITIONS:**
