To all consumers within the Cooperative's service areas, for controlled multiple street lighting systems, furnished lighting from dusk to dawn.

**TERRITORY:**

All electric residential and commercial consumers served by RCEC in Roosevelt County and extending into portions of Curry, Lea, Chaves and De Baca counties.

**CHARACTER OF SERVICE:**

Single-phase, 60 Hertz, at 120/240 Volts.

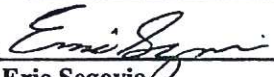

**TAX ADJUSTMENT:**

Billings under this schedule may be increased by an amount equal to the sum of taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state, and federal income taxes) payable by the utility and levied or assessed by any government authority on the public utility service rendered, or on the right or privilege of rendering the service, or any other object or event incidental to the rendition of the service.

**MONTHLY MINIMUM CHARGE:**

Shall be the monthly rate specified above, or as established in accordance with the Cooperative's Line and Service Extension Policy.

**FUEL AND PURCHASED POWER COST ADJUSTMENT:**

Billings under this schedule shall be increased or decreased by any amount that the purchased power cost for the previous month differs from \$0.069665/KWH sold, in accordance with NMPRC Rule No. 550.

**SURCHARGE:**

Billing under this schedule shall have a surcharge of 1% in order to procure renewable energy, invest in renewable energy projects or promote energy conservation and load management.

**TERMS OF PAYMENT:**

All bills under this rate are due and payable when rendered, and become delinquent twenty (20) calendar days after the billing date.

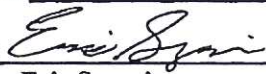
**LIMITED INVESTMENTS:**

The maximum investment per lamp at the quoted wattages in the Net Rate/Month shall not exceed the cost of fixture and installation cost on an existing cooperative owned structure. Any additional construction required will be paid by the consumer prior to construction.

**CONDITIONS OF SERVICE:**

The Cooperative's filed rules apply to service under this schedule.
