#### CHARACTER OF SERVICE:

Alternating current, 60 Hertz, at available secondary voltages.

#### MONTHLY DISTRIBUTION RATE:

Customer Charge – all customers \$52.50 per month X

#### MONTHLY RATE:

First 115 KWH/HP/Month \$.138100/KWH
Over 115 KWH/HP/Month \$.093100/KWH

# TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state, and federal income taxes) payable by the utility and levied or assessed by any government authority on the public utility service rendered, or on the right or privilege of rendering the service, or any other object or event incidental to the rendition of the service.

#### IDLE SERVICE RATE:

Consumers classified under this rate schedule may retain existing electric facilities (disconnected) on their premises by paying 60% of the established monthly minimum bill each month thereafter.

# MINIMUM CHARGES:

The monthly minimum charge under this schedule shall be \$2,50/HP/Month, but not less than \$52,50/Month.

The monthly minimum charge specified herein shall not be less than established in accordance with the Cooperative's Line Extension Policy.
