### TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state, and federal income taxes) payable by the utility and levied or assessed by any government authority on the public utility service rendered, or on the right or privilege of rendering any service, or any other object or event incidental to the rendition of the service.

## IDLE SERVICE RATE:

Consumers classified under this rate schedule may retain existing electric facilities (disconnected) on their premises by paying 60% of the established monthly minimum bill each month thereafter.

# DETERMININATION OF BILLING DEMAND:

The Billing Demand shall be the greater of:

- The maximum kW demand established by a consumer for any fifteen-minute integrated period during the billing period.
- 2. The Contract Demand

#### MONTHLY MINIMUM

The monthly minimum charge shall be the greater of:

- The billing charge resulting from the application of the Monthly Customer and Demand Charge
- 2. Contract Minimum

# PRIMARY METERING FOR DISTRIBUTION PRIMARY AND SECONDARY SERVICE LEVELS:

The Cooperative shall have the option of metering at secondary voltage and adding the estimated transformer losses to the metered kilowatt hours and kilowatt demand.

If the consumer owns and maintains all facilities past the metering point, the Distribution Primary Level Service rate shall apply.

## POWER FACTOR ADJUSTMENT:

The Cooperative may install suitable power factor measuring devices, and increase the measured kilowatt (KW) of demand one (1)% for each one (1)% the power factor is less than 95% during the billing period.
