# FUEL AND PURCHASED POWER COST ADJUSTMENT:

Billings under this schedule shall be increased or decreased by any amount that the purchased power cost for the previous month differs from \$.069665/KWH sold, in accordance with NMPRC Rule No. 550.

#### SURCHARGE:

Billing under this schedule shall have a surcharge of 1% in order to procure renewable energy, invest in renewable energy projects or promote energy conservation and load management.

# TERMS OF PAYMENT:

All bills under this rate are due and payable when rendered, and become delinquent twenty (20) calendar days after the billing date.

### TERMS AND CONDITIONS:

Capacitors must be installed and maintained on all three-phase motors as a condition of service. They must be sized according to the horsepower rating of the motor(s) as per the following table.
